RE: VAR-0016/NOD-0016: Site Facilities and Access to Laydown 14/15 – Variation Impact to Contract

Further to previous notice provided by the Contractor outlining the additional works associated with the Laydown 14 re-grading, the hereby notifies the Engineer:

- 1. the Works associated with the Variation are complete;
- 2. of the final impact to the Contract Price for the Works associated with this Variation; and
- 3. the Delay Event has ceased, and the Contractor will prepare an extension of time Claim (with reference to Clause 56.2(c)).

As part of this notification the Contractor refers to the following documents:

- 1. Letter reference CPB-1005-LET-0019 from the Contractor, titled "VAR-0016 and NOD-0016 Site Facilities and Access to Laydown 14/15", issued 22 February 2023.
- 2. Dayworks Dockets issued to the Engineer, over period 18 February to 1 April 2023.

## 1. DETAILS

On 22 February 2023 the Contractor notified the Engineer of a potential Variation in relation to the additional works required for Laydown 14/15, noting the area was not handed over in the condition ready for the Contractor and included a statement of an order of magnitude of \$120,000 impact to the Contract Price (refer **Attachment 1**, Letter *CPB-1005-LET-0019*).

#### 2. IMPACT OF VARIATION ON CONTRACT PRICE

As the Works have been completed, the Contractor notes the total impact of the Variation on the Contract Price is \$96,757.35. The financial breakdown of these costs has been included in **Attachment 2** (*Financial Breakdown of Costs*) for reference of the Engineer. The costs are the sum of the plant and labour on provided dayworks dockets applied with Contract rates applied as appropriate (refer **Attachment 3** *Dayworks Dockets*).

The Contractor acknowledges no Variation Direction has been received to date, however requests that the Engineer issues a determination confirming the Variation and values the Variation in accordance with Clause 9.3 of the Contract and in consideration of **Attachment 2**.




# 3. DELAY IMPACT
